She agrees that she is not under contract with any person, firm or corporation that would prevent her appearance or participation in the International competition and agrees to indemnify Angel Events for any claim etc that may be brought against it in this regard. She understands that she must be of good moral character and health. A medical form must be completed indicating any medical problems that she may have at the relevant time and all responsibility in this regard shall be that of the Candidate.
2. Candidates will not consumer any alcoholic beverages, use illegal drugs or publicly smokes during the course of the entire pageant. Points will be deducted if the delegate is caught engaging in these activities.
3. Candidates agree that the judge's prior decision is final, absolute and binding. Upon request, she can receive her score two weeks following the competition at the Mrs. Madhya Pradesh Home office.
4. Mrs. Madhya Pradesh / SIT XpressN directors, officers and sponsors etc are not responsible, accountable or liable in any manner whatsoever for any personal injury to anyone or damages/ compensation etc on account of any event, incident, cancellation/ change in the rules and regulations or change in dates of the events or for any happening of any kind whatsoever, prior to or during or after the event.
5. The Winner will forfeit all awards and privileges if she breaks her obligatory contractor do not meet all requirements set forth within this agreement. The award would then be given to the first runner up.
6. She further understands that the inability to fulfill her contract may result in the forfeiture of her title and all prizes must be returned and shall be liable for any loss/ damage that be suffered by Mrs. Madhya Pradesh / SIT XpressN Events. Her successor will take her place for the remainder of the year.
